YOU ARE REQUIRED TO ATTEND TWO SEPARATE EDUCATIONAL COURSES AS PART OF YOUR FAMILY COURT CASE:

REQUIRED COURSE #1:

PURSUANT TO LOCAL RULE 68.8, IF YOU ARE A PARTY TO AN ACTION THAT INVOLVES CUSTODY OR VISITATION OF A MINOR CHILD, YOU ARE HEREBY NOTIFIED YOU ARE REQUIRED TO ATTEND A COURT APPROVED PROGRAM DESIGNED TO EDUCATE PARENTS ON THE DETRIMENTAL EFFECT OF PARENTAL CONFLICT ON CHILDREN AND HOW TO AVOID SUCH CONFLICT. YOUR ATTENDANCE IS MANDATORY AND MAY BE WAIVED ONLY BY THE JUDGE.

THESE EDUCATIONAL PROGRAMS ARE DEVELOPED AND RUN BY PRIVATE PROVIDERS—THEY ARE NOT COURT PROGRAMS, BUT ARE COURT APPROVED. YOU MAY ATTEND ANY CLASS ON THIS LIST. THERE IS A COST FOR THESE CLASSES AND YOU MUST CONTACT THE PROVIDER DIRECTLY.
